Chair Blue McClellan introduced the directors present and the TUC contract positions.

#### **Presentation & Approval of 2012 AGM minutes**

Motion to approve the minutes of the 2012 AGM that took place on November 5<sup>th</sup>, 2012; Moved by Blue McClellan. Motion approved unanimously.

#### **Report from TUC Board of Directors**

President Nat Fitzgerald presented an overview of the Board's accomplishments during the year.

- First annual Board retreat
- RMI Monarch Park Stadium partnership a resounding success
- Updating policies, new ByLaws
- New league initiatives like parity league, 3:3 ratio leagues, masters, youth
- New partnership with Toronto Rush great exposure for the Club

# Review of 2012 Financial Statements and Financial Report

Cory Lamothe presented an overview of the 2012 fiscal year and the financial position for 2013 and beyond.

- Finished 2012 with a slight profit of \$2,665
- League field expenses up 9.8% from previous year due mainly to permit cost increases
- Explanation of the RMI loan, repayment schedule, and the use of the TUC Fields Fund
- Fields Fund currently sits at \$72,827 with initial repayment coming back July 1
- Absent the field fund, the Club is in a strong financial position with general operating funds
- Change of fiscal year from calendar year to April 1 March 31 to better align with our operations
- Change to a review engagement from a full audit as it is not necessary for the Club
- Overview of the budget for 2013

## **Report from TUC General Manager**

Jason Robinson (General Manager) presented an overview of TUC's operations for 2012-2013, including an update on membership, fields, leagues, partnerships, and the upcoming U23 Championships.

- Reached our highest membership total in 2012 (3404)
- RMI Monarch Park partnership is strong. We need to improve dome setup volunteerism
- Central Tech CI is very likely to be developed by RMI with TUC as a main tenant along with Ryerson University
- Active participation with TDSB and City of Toronto regarding fees, field maintenance, etc.
- More leagues than ever; tweaks to be made with indoor due to MPS fields
- Spring & Summer numbers strong up 9 summer teams from last year
- New partnerships with Toronto Rush and KIND Snacks, as well as new TUC logo
- U23 Championships preparation in full swing: 38 teams attending, \$300,000 budget

# **Appointment of Auditor for 2013**

Motion to approve Goldstein & Paloc, Chartered Accountants, as auditors for 2013; moved Blue McClellan. Motion approved unanimously.

#### Approval of New ByLaws

Motion to ratify the new By-Laws as approved by the TUC Board of Directors on April 10, 2013; moved by Blue McClellan.

The new ByLaws are a more cohesive document as a whole. They provide better governance and comply with the government changes to the Not-For-Profit Corporations Act. Substantive changes to the ByLaws include:

- Size of the Board
- Additional controls on notification
- Consolidating the Executive of the Board
- Definitions of our membership structure

Motion approved unanimously.

#### Election of new Board Members for 2013-2014 term.

The term is normally 2 years; however this term will be 1.5 years due to the need to host another AGM within 6 months of the stump fiscal year (January 1 – April 31). Nine new Board member spots were available, with 10 nominations being put forward.
